In schools: 1,176 teachers trained, who impacted 14,112 students, while impacting 250 students each day. In the Community: over 1,000 people trained, over 300 taught at a deep level, while impacting 200 people each month. We also continued development on our software to teach mindfulness in the school system.

Leadership training program: Unique for its rigor, length, and standards, this program creates leaders who manifest thorough mindfulness and extraordinary responsibility.
